

**2023 SHELL LUBRICANTS DISTRIBUTOR CHALLENGE RACE TO CHEER ON
SCUDERIA FERRARI IN AUSTIN, TX CONTEST**

OFFICIAL RULES

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR
PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.

1. ELIGIBILITY: The Shell Lubricants Distributor Challenge Race to Cheer on Scuderia Ferrari in Austin, TX Contest (“**Contest**”) is open only to eligible Premier & Prestige Shell Lubricants Distributor owners/principals or their Designees, (as defined below), who: (i) are owners/principals of or employed by and in good standing with a Premier & Prestige Shell Lubricants Distributor, (as defined below), located in the fifty (50) United States or the District of Columbia (collectively, the “**U.S.**”) as of April 1, 2023 through the dates the Prize, as defined in Section 5, is awarded and fulfilled, (ii) are a Premier & Prestige Janus contracted distributor as of April 1, 2023 through the date the Prize, as defined in Section 5, is awarded and fulfilled, (iii) are enrolled and in good standing in the Road to the Championship (“**RTTC**”) as of April 1, 2023; (iv) are legal residents of and currently residing in the U.S., and (v) are at least twenty one (21) years of age as of April 1, 2023 (or the legal age of majority in their state of legal residence, whichever is older). Employees of Pennzoil-Quaker State Company d/b/a SOPUS Products (“**Sponsor**”) and its parent, affiliates and subsidiaries, participating advertising and Contest agencies, including but not limited to those entities involved in the preparation of materials for administration and/or execution of this Contest (collectively “**Contest Entities**”) and their immediate family members (spouse, parent, child or sibling) and/or those living in the same household (whether or not related) are ineligible. A “**Premier & Prestige Shell Lubricants Distributor**” is defined as a lubricants distributor that has signed a Shell Lubricants Premier & Prestige distributor agreement effective as of April 1, 2023 through the dates the Prize is awarded and fulfilled. A Premier & Prestige Shell Lubricants Distributor principal may designate an eligible employee from their Senior Leadership, Sales, or Marketing team as their “**Designee**” to receive the Prize, if applicable.

Potential Winners (as defined in Section 4) are subject to determination of eligibility and verification by Sponsor or its authorized representative before any Prizes will be awarded. This Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. By entering in this Contest and accepting a Prize, all Entrants (each an “**Entrant**”; collectively “**Entrants**”) and Prize Winners (as defined in Section 6) agree to be bound by these Official Rules and the decisions of the Sponsor and/or its authorized representative, which are final and binding in all matters concerning this Contest. Winning a Prize is contingent upon fulfilling all requirements set forth herein.

2. CONTEST PERIOD: The Contest begins at 12:00 AM Central Time (“**CT**”) on April 1, 2023 and ends at 11:59 PM CT on August 31, 2023 (“**Contest Period**”).

3. HOW TO ENTER: There are two (2) ways to enter the Contest (each an “**Entry**”; collectively “**Entries**”).

A. Purchase Entry Method: Eligible Premier & Prestige Shell Lubricants Distributor owners/principals will be automatically entered in the Contest (“**Contestants**”). Contestants will receive one (1) entry for each month they meet their Janus plan during the Contest Period.

Note: Premier & Prestige Shell Lubricants Distributors within the Shell Lubricants network under the Janus Contract are assigned monthly plans (gallons of product purchased from Shell) according to the level of the contract they negotiated.

- B. Alternative Entry Method:** If an eligible Premier & Prestige Shell Lubricants Distributor owner/principal does not want to make a purchase to meet their monthly Janus plan, as set forth in Section 3A, an Entrant alternatively may receive an Entry by legibly hand-printing in black or blue ink on a 3" x 5" card his/her first and last name, street address, city, state, ZIP code, email address, and daytime telephone number (optional) and mailing the card with first class postage affixed to: Shell Lubricants Distributor Contest, Offer #O2470, P.O. Box 809004, Houston, TX 77280-9921. Only one (1) mail-in Entry per postmarked envelope. Mail-in submissions must be postmarked by August 15, 2023 and received by August 31, 2023 to receive an Entry into the contest. Illegible, incomplete, inaccurate, lost, late, misdirected, stolen, delayed, damaged, postage due, machine printed, typewritten or mechanically reproduced mail-in Entry submissions will not be accepted. An Entrant's submission of an Entry by mail certifies that he/she (i) is satisfying all eligibility requirements set forth herein, and (ii) has read and complied with the terms and conditions of these Official Rules.

Limit of five (5) entries per eligible Premier & Prestige Shell Lubricants Distributor owner/principal, regardless of entry method, during the entire Contest Period.

All entries are subject to verification by Sponsor, whose decisions are final and binding. Only eligible Entries received by Sponsor in accordance with the terms and conditions set forth in these Official Rules will be eligible for the Prize drawing.

- 4. PRIZE DRAWING:** On or about September 15, 2023 at or about 1:00 p.m. CT, Sponsor or its authorized representative will randomly select three (3) potential winners from all eligible Entries received by Sponsor in the Contest (each a "**Potential Winner**"; collectively, "**Potential Winners**").

Each Potential Winner will be contacted by Sponsor or its authorized representative via email and/or phone at the business email address and/or telephone number on file with Sponsor as of September 15, 2023. Sponsor will attempt to contact each Potential Winner two (2) times to notify him/her that he/she is a Potential Winner and to provide him/her with instructions regarding the information and/or documentation required in order to receive the Prize, defined in Section 5.

Potential Winners should regularly check their emails and/or voice mails to ensure they do not contain any Contest notifications. If the Sponsor or its authorized representative is unable to contact a Potential Winner after two (2) attempts via email and/or phone or in the event that a Potential Winner fails to provide the required information and/or documentation within the time period specified by Sponsor, then his/her Prize, defined in Section 5, will be forfeited and Sponsor may, in its sole discretion, select an alternate potential winner, time permitting.

- 5. PRIZES (3):** Subject to the terms and conditions of these Official Rules, a maximum of three (3) Prizes will be awarded in connection with this Contest. Each "**Prize**" consists of a trip for the confirmed Winner (as defined in Section 6), and three (3) eligible employees of his/her choosing from his/her Senior Leadership, Sales, or Marketing team to the Grand Prix in Austin, TX (the "**Race**"), arriving on October 19, 2023 and departing on October 23, 2023. Each trip includes roundtrip coach class airfare for four (4) between the major commercial airport closest to the Winner's residence (as determined by Sponsor in its sole discretion) and Austin, Texas; five (5) days and four (4) nights' hotel accommodations in up to four (4) standard, single occupancy rooms at a hotel selected by Sponsor in its sole discretion; four (4) tickets to the Race; transportation between the hotel and Race; and a \$1,000 Visa® Rewards

Card that may be used towards transportation to/from the airport and hotel, miscellaneous expenses, and/or incidentals.

Each Winner must be able to travel on the dates set forth by the Sponsor or the Prize will be forfeited. If a Winner resides within a 200-mile radius of Austin, Texas, a \$250 Visa Rewards Card may be provided for ground transportation in lieu of air transportation and no compensation will be provided for any difference in Prize value. Travel dates are subject to availability, blackout dates, and any other applicable restrictions that may apply (including but not limited to reasons related to the COVID-19 pandemic, as more particularly described below). If a Potential Winner is unable or unwilling to travel (including for reasons of noncompliance with restrictions and vaccination requirements related to COVID-19) on the dates specified by Sponsor, his/her Prize will be forfeited.

Each Winner is solely responsible for obtaining any desired or necessary travel documents (including but not limited to government identification and COVID-19 testing, vaccination records, and/or quarantine required by U.S. authorities) and to obtain and maintain applicable insurance at their own cost and expense. **Winners are responsible for all travel expenses not included herein, including but not limited to airline baggage fees, gratuities, meals, airport fees, parking fees, in-room charges at the hotel (e.g., room service, mini-bar, movies), telephone calls, meals, beverages, upgrades, personal incidentals, amenities and any other incidental costs, fees, and/or expenses not specifically mentioned in these Official Rules.** Travel is subject to the restrictions and conditions set forth below. All travel must be booked prior to arrival. Travel is subject to capacity controls, Travel Rules (as defined below), availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. No changes will be made to travel details once any elements of the travel arrangements have been booked, except at Sponsor's sole discretion. Travel is subject to the terms and conditions set forth in these Official Rules and those set forth by Sponsor's travel prize supplier, as detailed in any contract issued by such supplier. All hotel and other booking arrangements will be administered by Sponsor and/or Sponsor's authorized representative. Winners agree to comply with all of the hotel's requirements, including but not limited to any requirement by the hotel for each Winner to provide a valid credit card to the hotel upon check-in for incidentals or otherwise which are not included in the Prize. Sponsor is not responsible for changes in schedule of any element of the Prize or for any expenses incurred as a consequence of flight cancellation or delay. Sponsor is not responsible and will have no liability if a Winner is for any reason not permitted to travel by the relevant airport or government authorities or misses a flight or other travel element (including due to causes related to COVID-19 or other public health reasons). Sponsor reserves the right to add, substitute, change, or modify travel related elements in its sole and absolute discretion.

Each Winner must execute and return a travel liability release before any ticketing or travel will be booked. Winners understand that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In the Winner Affidavit, defined in Section 6, each Winner hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance (including but not limited to medical insurance) for any part of the trip.

Prize related events and activities are subject to raincheck, modification and/or cancellation policies and procedures of the event organizers and fulfillment parties. Sponsor is not responsible if any element or activity of the Prize is delayed, postponed, or canceled for any reason (including but not limited to any cancellations or delays caused by the COVID-19 pandemic). Winners will not receive compensation from Sponsor for any element of the Prize that the Winners are unable to use due to cancellation of any element or activity provided as part of the Prize, including but not limited to any travel costs paid for by the Winner to accept and/or attend Prize related events and/or activities, but tickets may be subject to standard rain-check policies and procedures set by the issuer. Lost, stolen, damaged or destroyed tickets will not be replaced. Resale of tickets is prohibited. Each Winner must abide by all Race venue

policies. Sponsor and/or Race venue personnel reserve the right to remove or to deny entry to or revoke full or partial Prize elements from any Winner who they deem, in their sole discretion, have violated the previous restrictions or engaged in a disruptive manner or with intent to abuse, threaten, or harass any other person or any of the Contest Entities at the Race, be intoxicated, a safety risk, have violated any Race venue policy or law, or may bring Sponsor into disrepute.

Prize must be accepted as awarded. No assignment, transfer or substitution of the Prize, in whole or in part, is permitted, except that Sponsor reserves the right in its sole discretion to substitute the Prize, or a portion thereof, with a prize item or items of equal or greater value, if the Prize (or any portion thereof) cannot be awarded for any reason (including but not limited to any cancellations or delays caused by the COVID-19 pandemic), as determined by Sponsor in its sole and absolute discretion, without liability. Prize cannot be exchanged or redeemed for cash.

Note: Winners irrevocably waive all claims against the Released Parties and agree that the Released Parties will have no liability or responsibility for any claim arising in connection with participation in this Contest, the prize elements awarded, personal injury, or wrongful death, a potentially heightened risk of exposure to communicable diseases, viruses, bacteria or illnesses, including COVID-19 and the causes thereof, and sickness arising as a result of the winner participating in the Contest and related activities, wherever, whenever or however the same may occur. Prize winner fully understands that **(a)** COVID-19 is extremely contagious and there is an inherent risk of exposure to COVID-19 in any place where people are or have been present; **(b)** no precautions, including the protocols that will be implemented from time to time by any/all travel providers or those providing accommodations, can eliminate the risk of exposure to COVID-19; **(c)** while people of all ages and health conditions have been adversely affected by COVID-19, certain people have been identified by public health authorities as having greater risk based on age and/or underlying medical conditions; and **(d)** exposure to COVID-19 can result in being subject to quarantine requirements, illness, disability, other short-term and long-term health effects, and/or death, regardless of age or health condition. Notwithstanding any of the foregoing, participation in this Contest is subject to restrictions imposed by state, local, and territorial governments including (but not limited to) testing requirements, vaccination requirements and/or documentation, stay-at-home orders, and quarantine requirements upon arrival (collectively, "**Travel Rules**").

Limit one (1) Prize per Winner.

The Approximate Retail Value ("**ARV**") of each Prize is \$10,484.88. **The total ARV of all Prizes is \$31,454.64.**

6. HOW TO CLAIM A PRIZE: All Potential Winners will be notified by Sponsor or its authorized representative on or about September 15, 2023. A Potential Winner is not a "**Winner**" until all eligibility criteria have been verified and the Potential Winner has been notified that verification is complete and any necessary documentation has been properly submitted to Sponsor or its authorized representative.

Each potential Winner will be required to execute and return a Declaration of Eligibility/Liability & Publicity Release (“**Winner Affidavit**”) no later than three (3) business days from the date that the Potential Winner is contacted, or the Prize may, in Sponsor's sole discretion, be forfeited. If a Potential Winner fails to execute the Winner Affidavit, is found to be ineligible or not in compliance with these Official Rules; or declines to accept the Prize, then the Prize will be forfeited, and the Sponsor may, in its sole discretion, award the Prize to an alternate potential winner, time permitting.

Potential Winners may be required to furnish proof of identification and other proof of eligibility under these Official Rules. All federal, state, and local taxes, and any other applicable costs or fees not specifically referenced in these Official Rules, are solely the responsibility of each Winner. Any valuation of the Prize stated above is based on available information provided to Sponsor at the time these Official Rules were published, and the value of the Prize awarded may be reported for tax purposes as required by law. An IRS Form 1099 will be issued to each Potential Winner by Sponsor or its authorized representative in the amount of the total Prize value, and the Potential Winner must provide Sponsor or its authorized representative with his/her social security number or taxpayer identification number to receive the Prize.
